Groupe Acrotec SA announces result of Tender Offers

On 20 September 2021, Groupe Acrotec SA ("Acrotec" or the "Company") announced an invitation to holders in respect of its outstanding CHF 70,000,000 3.75% bonds due 14 June 2023 (the "2023 Bonds") and CHF 75,000,000 3.5% bonds due 16 October 2025 (the "2025 Bonds") (together the "Acrotec Bonds", and the holders thereof the "Bondholder(s)") to tender any-and-all for cash (the "Tender Offers"), subject to the terms and conditions outlined in the information memorandum dated 20 September 2021 (the "Information Memorandum").

The new expiration date for the Tender Offers was noon (CEST) on 22 October 2021 (the "New Expiration Date"), as per the announcement by Acrotec on 11 October 2021, regarding the extension of the Tender Offers.

The total amount of Acrotec Bonds which were validly tendered after the original Expiration Date, but prior to the New Expiration Date that the Company has accepted for purchase is CHF 865,000.

The table below contains a summary of the total aggregate principal amount of Acrotec Bonds the Company has accepted for purchase pursuant to the Tender Offers following the New Expiration Date.
