Ad-hoc announcement pursuant to Art. 53 LR

Groupe Acrotec SA ("Acrotec" or the "Company") announces invitation to holders of certain of its outstanding bonds to tender any-and-all for cash

Today, Acrotec announced an invitation to holders of its outstanding CHF 70,000,000 3.75% bonds due 14 June 2023 (the "2023 Bonds") and CHF 75,000,000 3.5% bonds due 16 October 2025 (the "2025 Bonds") (together the "Acrotec Bonds", and the holders thereof the "Bondholder(s)") to tender any-and-all their Acrotec Bonds for cash (the "Tender Offers"), subject to the terms and conditions outlined in the information memorandum dated 20 September 2021 (the "Information Memorandum").

The Tender Offers will expire at noon (CEST) on 8 October 2021 unless previously terminated or extended, and are expected to settle on 22 October 2021.

Bondholders who tender their Acrotec Bonds will be paid a consideration that includes accrued interest from the last interest payment date up to the settlement date and a purchase price. The table below shows the relevant tender offer consideration payable for each of the Acrotec Bonds.

The Tender Offers are being made as part of the Company's ongoing pro-active balance sheet management. Acrotec Bonds purchased by the Company pursuant to the Tender Offers will be cancelled and will not be re-issued or re-sold.

The terms and conditions of each of the Acrotec Bonds allow the Company to redeem the Acrotec Bonds early (in whole but not in part), at par plus any accrued interest, on the date determined by the Company for early redemption, if 85% or more of the principal amount issued has been redeemed or purchased and cancelled. It is the current intention of the Company to make use of the clean-up call, in accordance with the Acrotec Bonds' terms and conditions, if the 85% threshold is reached or exceeded after the settlement of the relevant Tender Offers.

If the 85% threshold is not reached, the Company may – in its sole discretion – continue to make purchases of outstanding Acrotec Bonds on the open market or otherwise. The Company however has no obligation to use the clean-up call or to make any purchase of the Acrotec Bonds after the settlement of the Tender Offers, and the Company's intentions are subject to change at any time and for any reason. No assurance can be given that the 85% threshold described above will or will not be met in respect of any of the Acrotec Bonds.

As of the date hereof, 57.6% of the aggregate principal amount originally issued in respect of the 2023 Bonds and 71.6% of the aggregate principal amount originally issued in respect of the 2025 Bonds has been purchased and cancelled

Further purchases of CHF 19.2 million in nominal amount in respect of the 2023 Bonds, and CHF 10.1 million in nominal amount in respect of the 2025 Bonds would allow the Company to reach the required threshold to enable it to enact the clean-up call.
